Mike recently acted for the owners of the "Costa Concordia" and their liability insurers in relation to that vessel's grounding and capsizing. In May 2012, he was listed by Tradewinds as one of the world's top 5 lawyers for shipping emergencies, and in December 2013 he was named in Lloyds List's "top 100 most influential people in the shipping industry".
